he shall is so required by the Government any other rural areas of the state from minimum period of one year service in any of the tribal areas of the state as prescribed thereof and shall furnish suitable bond for the due performance of the said conditions. AND WHEREAS the student who had said course in Gujarat Medical Education and Research Society- Medical College Sola (hereinafter referred to as "the said College") has been admitted for the said course.

NOW the condition of the above written obligation is that if the student

1. Diligently prosecute and complete the said course at the said college or any other Medical college in the Gujarat Medical Education and Research Society and pass the prescribed university examination for the said course and
2. Within a period of thirty days from the date of his completing the date of his completing the period of internship or rotating horsemanship give to the Govt. by registered post notice in writing intimating the completion of his period of internship or rotating horsemanship provide however that if the student is desirous of counting post –graduate studies such notice shall expressly specify such desire and request studies and it shall be open in the Government in its absolute discretion to refuse such permission or to grant it subject to the condition that the student shall within one month from the completion of post graduate course give a like notice to the Government and
3. When called upon by the Government at any time within a period of six months from the receipt of the notice from the student as aforesaid join the state service and serve in any of the rural areas of the state for minimum period of one year at such remuneration as may be prescribed thereof and in the event of the student not being so called upon by the Government to join the state service and serve them for aggregate period of one year in any of the rural areas of the state and during the student is serve under the provision of this Bank guarantee faithfully discharge the duties assigned him by the Govt. or his order superiors with utmost diligence and efficiency and shall observe the rules for time being in force regulation the conduct person so serving .
4. Then the above written bank guarantee shall become void otherwise the same shall remain in full force and Virtue.
